students traveled to Brazil, the middle school students to Utah, and
the K-5 students explored various sites in Colorado.
Another area of emphasis is the outdoor and live skills program. The ski and
snowboard program for grades 4-12 is the largest segment. Students K-3
participate in a swimming program. High school students earned Wilderness
First Responder and Wilderness First Aid certifications.

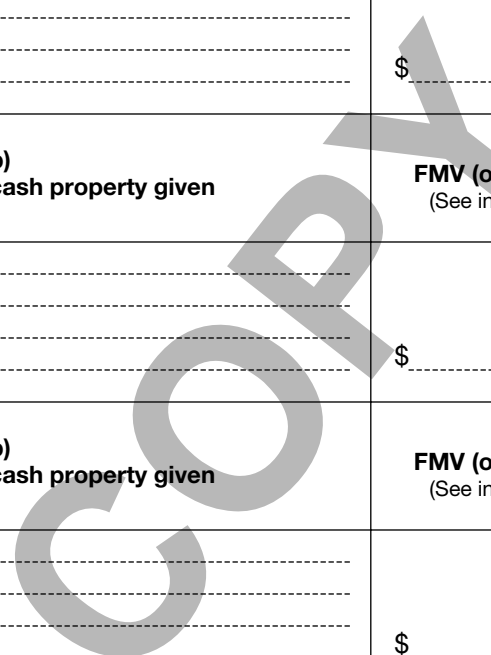
